

Horizon 2020 European Funding for SME R&D Projects

R&D grants can provide an essential source of match funding for your innovative project. However, applying for R&D grant funding can be difficult and time consuming. Understanding the rules for the Horizon 2020 SME instrument

The SME instrument helps high-potential SMEs to develop ground-breaking innovative ideas for products, services, or processes that are ready to face global market competition. Highly innovative SMEs with a clear commercial ambition and a potential for high growth and internationalisation are the prime target.

Funding is available for:

- Phase 1 – Concept and production of a technical and commercial feasibility assessment, including a business plan, for a breakthrough innovation. Funding is provided as a lump sum of €50,000. Projects should last around 6 months.
- Phase 2 – Activities aimed at bringing innovation projects to investment readiness and maturity for market take-up. Innovation projects must be underpinned by a sound and strategic business plan, and should last between 12 and 24 months. The amount of funding ranges from €500,000 to €2.5 million, covering up to 70% of eligible costs.

What types of projects are suitable for R&D grant funding?

An effective R&D grant application successfully describes the commercial, technological, and financial benefits of the project in a precise and compelling manner. R&D grants are often awarded to projects considered too risky for private sector investment.

Proposed R&D projects and costs must also be realistic, with a clear commercial opportunity, and aim to create new markets or exploit significant growth.


